End of year closure dates

KEL will close for the year on **Friday the 20th of December** at 2.30 pm. We will open again in the new year on Monday the 6th of January.

N.B. It would be very helpful if you would let us know when you expect your tamaiti to return so we can manage staff leave over the period.

Whānau/Kaiako Hui - Week beginning 11th November

All whānau are invited to book a time for a catch-up with kaiako during the week beginning **11th November.**

This is an opportunity for whānau to sit down and work alongside key kaiako to develop a plan of learning and outcomes for tamariki. We recommend that you take up the opportunity to share your thoughts, talk through any concerns and hear from kaiako about how things are progressing for your tamaiti.

Family Boost

As from 1 October families are able to apply to IRD for Family Boost assistance with their childcare costs. On the 2nd of October therefore, we sent you a statement showing fees you were charged for the period 1 July to 30 September. From now on, you will receive a statement at the end of every 3 month period.

The amount you can claim will depend on your household income and the childcare fees you pay. The maximum you can receive is \$975 per quarter (every 3 months).

If you wish to apply to IRD for Family Boost funding, you will need to upload the quarterly statements we send you, to IRD via your myIR account. If you are eligible you will need to submit a claim once every 3 months – retrospectively.

Registering for FamilyBoost on myIR

To register for Family Boost you will need an myIR account. If you don't have an myIR account go to:

ird.govt.nz/myir-personal to set one up.

To register for FamilyBoost on myIR, you will need to:

- Log in to myIR.
- Select 'I want to'.
- Search for 'FamilyBoost' in the search tab.
- Select 'Register for FamilyBoost'.
- Complete your details and 'Submit'.

You will need to have the following details ready:

- New Zealand bank account details.
- Details of each eligible child attending ECE:
 - full name
 - o date of birth
 - IRD number.

(If you need to apply for an IRD number for your child, you'll need to visit: <u>ird.govt.nz/ird-number-nz</u>)

- Your partner's details (if you have one):
 - o full name
 - \circ date of birth
 - o IRD number (optional).

You will also need to give the name and address of KEL: *Kilbirnie Early Learners, 58 Bay Road, Kilbirnie.*

Annual General Meeting - February/March 2025

Annual reports will be presented and we will elect the governance committee for the year ahead. KEL is an incorporated society governed by a committee of parents. The committee determines and develops the centre's strategic direction, reviews our policies and procedures on a regular basis, employs and supports our kaiako and generally keeps the centre on task.

The committee meets once every six weeks. By becoming a committee member, you can play an important role in shaping the early learning experience of your tamariki and help ensure that decisions made by the committee are in the interests of all tamariki who attend KEL.

Housekeeping & IMPORTANT! Reminders:

Nappies and wipes

Please remember to check your supply.

Naming items

Things are easily lost at KEL over the course of a busy day. Best practice is to name everything and keep precious toys at home.

Wet bags

Thank you to those who have provided wet bags for your tamariki, as we no longer have a supply of plastic bags these are a real help for messy/wet clothing.

Emergency kit snack boxes

We are wanting each whānau to provide us with a 2-litre ice cream container with snacks you know your tamaiti will eat, and medication such as inhalers for them. These must have a Drs label on it which shows expiry date and dosage. These will need to be turned over every 6 months

Signing in and out

Remember to sign in and out when you are dropping off and picking up. For safety reasons we need to know who is on the premises at all times during the day.

Confirmation of enrolment forms

Occasionally we ask whānau to <u>confirm</u> that they want their tamaiti to continue to attend KEL for their booked hours. This is because if tamaiti have been absent for a period or show irregular attendance, the Ministry of Education requires that we ask whānau to sign a form to confirm their booked days/hours. **Thank you!** to those whānau for supporting the Centre to comply with this MoE requirement.

Advise us of absences and illnesses

Please let us know if your tamaiti is going to be absent. We also want to know if your tamaiti is sick. Please let us know their symptoms so that we can protect everyone at KEL. Text or email is our preferred method of communication for absences.
